- **Establish locational guidelines** that are appropriate to the proposed project. These might include distance from a major metropolitan area, climate, proximity to competitors or natural elements such as the ocean or mountains, or frontage on high-traffic arteries requiring specific automobile or pedestrian counts.
- **Identify sites and/or cities that possess the necessary market** support for the planned project. Depending on the client's geographic constraints, this could involve a nationwide screen or could be limited to a specific metropolitan area or neighborhood.
- Screen candidate sites and/or cities in order to determine their desirability for investment or feasibility for a proposed project. This includes consideration of the demographics of the area, economic indicators, current development activity (including competition for the proposed project), desirability of the site in terms of access and transportation networks, physical development constraints, and related issues.
- Assist in acquisition of the site, including broker selection and management, specifying contingencies, finalizing the negotiation, and managing the settlement process.
